Use data and evidence when we compare ourselves to competitors.

Respect the law

Follow all applicable laws and regulations and do not tolerate any form of criminal behaviour.

Promptly report anyone we see breaking the law.

Hold off from political activity and never use company funds or resources to support any political party or candidate.

Always play our part in social responsibility, following ESG standards, integrating them into our business strategy and aiming to go beyond.

Always comply with securities and tax laws, never engage in insider trading, meet our tax obligations and never facilitate any form of tax evasion.

Comply with international laws including observing export controls, sanctions and customs laws.

Avoid and disclose conflicts of interest, reporting any perceived, potential or actual conflicts of interest when they arise.

Do not take shortcuts

Always choose what is right over what is easy. Even if it takes longer.

Are courageous while we always base our decisions on facts, reasoning, and our expertise.

Strive for continuous improvement and are accountable to our customers, our colleagues and ourselves.

Keep information safe

Protect both our customers' and our own property, information and data from misuse, theft and loss.

Report any breaches of data or safety as per our obligations.
